 - For the period covering November 2025, the District's Total Expenditures were \$23,573. Expenditures included \$7,230 in Payroll expenses, \$4,487 on UTV equipment, communications, and attachments, \$4,851 concerning vehicle repairs & fuel, and \$2,643 for rodent control, snow removal, and utilities. The remaining \$4,362 included general expenses, such as office supplies, ID printer, training & registration, newsletter, County Treasurer fees, insurance and software.

- We are coordinating with our vendor to get preventative maintenance completed on E82 and T83 completed before the end of the year. We are still working with the City of Golden fleet services on completing an IGA for vehicle maintenance for 2026, however the review process is taking longer than anticipated.
- On January 1, 2026, GGFDPD will be transitioning to NEIRs reporting with the rest of the country. Chief Enright has worked with ESO to ensure that the transition should be seamless for our staff, and we remain in compliance.
